The Russell Forest Trail Association, Inc. (the “Association”) is a not-for-profit organization whose purposes include management, preservation, and restoration of the land located near Alexander City, Alabama at Lake Martin. The Association also supports the potential of the communities within this area by providing ecological, cultural, recreational, and educational opportunities for community stewardship to the greater Lake Martin community.

Walkers/Hikers/Bikers/Golf Carts: Please bring completed application and release form to the Russell Lands office (2544 Willow Point Road, Alexander City), The Stables at Russell Crossroads (288 Stables Loop, Alexander City), or the Adventure Center at Russell Crossroads. The user will receive an association membership card and will be required to sign a release form.

Horse Riders: Please bring completed application and release form to the Stables at Russell Crossroads. The user will receive an association membership card and will be required to sign a release form.

Russell Lands On Lake Martin residents, Russell Lands cabin tenants, and Willow Point Golf & Country Club members will receive a 50% discount on association dues. NOTE: Homeowners subject to the Russell Forest Preservation Organization transfer fee receive membership at no charge.

The dues for membership in the Russell Forest Trails Association are defined below and expire annually on December 31.

- **Walkers/hikers** – must register with the Russell Forest Trail Association but no dues will be payable.
- **Bikers** – Annual and Day memberships must register with the Russell Forest Trail Association. *Bikers must yield to horses.*
Annual membership - \$20 includes a membership card and bike decal. The decal should be affixed to the seat post of the bicycle.
Day pass - \$10 for a day pass which should be on your person while on the trails.





- **Golf Carts** – Annual memberships must register with the Russell Forest Trail Association. Golf carts are allowed North of Russell Crossroads and limited to the Green Way. *Golf carts must yield to horses.*
Annual membership - \$100 includes membership card and decal to be displayed on golf cart windshield.
- **Horse Riders** – Annual Individual, Annual Family and Day memberships must register with the Russell Forest Trail Association. .
Annual Individual membership - \$100 includes a membership card and one vehicle decal to be displayed on the vehicle windshield.
Annual Family membership - \$175 includes 4 membership cards and one vehicle decal to be displayed on the vehicle windshield.
Day pass - \$25 pass which should be displayed in your vehicle windshield.

Verification of membership will be required for users of the trail system after June 1, 2011. Russell Lands security will check vehicles at trailheads for decals and users on the trails are subject to verification of membership by bike or golf cart decal or presentation of membership card.

Rules and Regulations

- **At least one member of each group must call security at 256-329-1511 and register upon arrival at the trailhead. There will be no exceptions to this rule. Any lone rider must call upon arrival and upon leaving.**
- **Four wheelers, motorcycles, all-terrain vehicles (ATVs), utility task vehicles (UTVs), and all motorized vehicles are prohibited, with the exception of approved Russell Lands related vehicles in the scope of approved business and golf carts with membership decals.**
- Alcohol, firearms, camping, overnight parking, open fires, cigarette smoking (during no-burn periods), horse racing, abusive language, and littering are prohibited.
- The trails are open for use from dawn till dusk.
- All vehicles must park at designated trailhead locations only.
- Dogs must be on a leash at all times while on trail property.
- Horse riders must stay on designated trails at all times. Horses are not allowed in construction areas on cabin roads or the Green Way. The trails are clearly posted.
- Due to the variety of trail users (horse riders, walkers, joggers, golf carts, and bikers), we ask that all users exercise appropriate etiquette, courtesy and patience while on the trail.
- Willful violation of any rule will result in immediate removal from the trail property and the possible loss of the privilege to return.
